

MLA Files Lawsuits Against NOAA on Wedge Closure

Today, Friday, February 9, 2024, the Massachusetts Lobstermen's Association (MLA) filed a lawsuit against the National Oceanic Atmospheric Administration (NOAA) arguing that their Final Rule to make permanent the closure of the Massachusetts Restricted Area Wedge (Wedge) and include the Wedge in the larger Massachusetts Restricted Area (MRA) annually, from February 1 to April 30 is unlawful under the Consolidated Appropriations Act of 2023 and is a continuation of NOAA's unlawful conduct, which the United States Court of Appeals for the District of Columbia previously held "relied upon worst-case modeling that is 'very likely' wrong, based upon assumptions [NOAA] concededly does not believe are accurate" and relies upon legal reasoning which is "egregiously wrong."

For over 40 years, the MLA and commercial lobstermen have been at the forefront of North Atlantic Right Whale (NARW) conservation efforts. Despite our longstanding and demonstrated commitment to protecting these whales, NOAA continues to demand more from us. NARW conservation remains a top priority in all our endeavors. However, despite Congress's explicit directive to refrain from interfering with the lobster industry, NOAA has left us with no choice but to pursue



NOAA Closes the Wedge Permanently




On February 2, 2024, NOAA finalized the rule to make permanent the addition of the Massachusetts Restricted Area Wedge into the larger Massachusetts Restricted Area (MRA) annually, from February 1 to April 30. The wedge will now be closed to commercial trap/pot fisheries during this time in order to reduce the immediate high level of risk of incidental mortality and serious injury to North Atlantic right whales in this area as part of the Atlantic Large Whale Take Reduction Plan.

In 2024, this restricted area will go into effect 30 days after publication to provide fishermen notice to remove their gear. This closure to persistent buoy lines will begin on Friday, March 8, 2024. In 2025, the larger MRA will go into effect on February 1.

This rule permanently addresses the risk created by this open wedge when large numbers of right whales are using and transiting through the area while trap/pot gear is actively being fished or stored in preparation for the May 1 opening of federal waters within the Massachusetts Restricted Area.

This closure to buoy lines was requested by the Massachusetts Division of Marine Fisheries. which expressed concern about the high density of gear and whales in this area based on previous years' observations. The area was closed through emergency action in 2022 and 2023. This rule permanently address-

Stellwagen Bank Advisory Committee Meeting #70

The Stellwagen Bank Advisory Committee (SAC) held its 70th meeting. The complexity of these meetings is robust and includes topics that are of simple, passing interest to some, to critical components of the future of our industry. The topics range from commercially viable seafood products to Maritime Heritage to offshore wind and much more. There is a fascinating array of individuals who donate their time and effort to these meetings, to the ideals of the sanctuary and to the successful operation thereof.

Those components with direct impact on our fishery include Offshore Wind, the North Atlantic Right Whale (NARW), forage species, specifically herring, the Wedge area, as well as other fisheries and interactions with those fisheries. Other important topics are educational outreach and mapping the Sanctuary. Maritime Heritage is fascinating yet doesn't have as much of an impact on fixed gear as it does on mobile gear.

Offshore wind and the NARW are the most ominous topics. We have seen the proposed lease areas for the wind projects. Although these proposed lease sites will be well to the east of the Sanctuary, the likely route for the transmission cables will likely pass through Stellwagen Bank Marine Sanctuary (SBNMS). There is an interesting overlap between Maritime Heritage here. The Maritime Heritage team is currently in the process of side-scan sonar, mapping as much of the Sanctuary as possible. This comes at an opportune time. The mapping program will be utilized in the decision-making process of locating potential corridors for these transmission lines.


There continues to be lots of talk about partnering with Bureau of Energy Management, (BOEM) for information purposes. The SAC is considering the prospect of offering a non-voting seat to BOEM for this purpose. This would be beneficial in terms of the process of locating transmission lines as well as streamlining information flow between the SAC & BOEM. Information is critical here. It was noted from the Mobile Gear Seat, Mark Gustafson, that there was a decision to not run a cable through Coxes Ledge because of its critical habitat status. This decision was rescinded and the process of running that cable through Coxes Ledge is now underway.

The SAC will actively coordinate with BOEM on a multitude of issues: permitting in the Sanctuary, routing, traffic management, on the national level, to include Offshore Wind transmission lines. It was noted that the companies responsible for the construction of Offshore Wind projects want nothing to do with the Sanctuary and its rules, as far as can be avoided.

Regarding NARW, we continue to be given the back seat based on the erroneous narrative on the subject. SBNMS supports increasing the closure to include the Wedge Area and to extend the closure north to the New Hampshire border and east to Area 3. It is my understanding, this extension of the closure would be in contravention to the Consolidated Appropriations Act, signed into law by President Biden in 2022, that stated, basically, no new rules or regulations for the Lobster and Jonah Crab fisheries until, at least, 2028. No one seems to have any concerns about this inconvenient fact. Some of the basic, exculpatory facts as to why WE are not to blame, were mentioned, as a note, but the recommendation had already been made by the SBNMS.

SBNMS has started a program that utilizes AIS to broadcast real-time data as to the location of NAWRs. As of now, there is only one AIS tower that has the additional equipment necessary for this "product". Superintendent, Peter DeCola, expressed high confidence in this product, noting that it would be an expensive rollout but could be utilized along the entire east coast. There's some interesting potential here as well as some potential downside for the fleet. I will do my best to keep you informed as I learn more.

As for the unfortunate NARW that ended up on Martha's Vineyard, the propaganda machine is fully engaged. We know it isn't us, but the public does not. Again, it was noted that it is unlikely that Massachusetts, or for that matter, any of the lobster fleet had anything to do with this entanglement. Kelly Whitmore of the Division of Marine Fisheries noted that the line did not have the color marking scheme used for Massachusetts and was not line that would be likely used in our fishery. She also noted the rollout of the Massachusetts specific,1,700 lb., breakaway, red line with the Massachusetts tracer ribbon embedded in it.



Forage species were discussed to a limited extent: Herring and sand lance. The concern for sand lance revolved around the scallop fishery and its destructive impact on the sandy habitat required by the sand lance for reproductive purposes. There have not been any decisions. rules, or regulations on this matter. For now, it is only a discussion as the "experts" try to determine the overall impact of the sand lance as a forage species. Amendment X is on the table regarding spatial and temporal management. There will be a panel discussion on the herring amendment at the Maine Fishermen's Forum at the beginning of

Marine Heritage is wound fully throughout the fabric of SBNMS. The history of the sinking of the Portland is going to be presented in the upcoming months in Portland, ME. The discussion will include the wreck itself and the timeline as well as the overall impact on the community of Portland. Probably the most famous wreck on the Bank. the Portland has been photographed and studied quite extensively. With the data the Sanctuary scientists have retrieved, they have been able to build a 3D model of the ship. It

is wildly impressive. The location of the vessel has remained tightly guarded to keep folks away from it. What I can say is that it has some nets on it and is relatively very deep. I, for one, am very interested in seeing the final presentation of the Portland wreck.

The educational and outreach initiatives of the Sanctuary are quite extensive. The biggest push in years is the upcoming construction of a facility in Provincetown. This should be a huge win in terms of bringing further awareness to Stellwagen and the amazing biodiversity that thrives there.

Two final notes: Deputy Superintendent, Ben Haskell will be leaving in July. Ben has dedicated 31 years of his life protecting Maritime Heritage and fighting to preserve nature! There is a vacancy for the Fixed Gear Alternate seat at the SAC. If anyone is interested, please contact Eric Meschino, Beth Casoni, or SB-NMS directly to inquire. The more we stay engaged, the better chance we will be able to move the needle in our favor.

Juvenile Lobster PREDATION

A research team asks: Who's eating young lobsters?

EXPLORE the PROJECT

Atlantic cod, red hake, white hake, Atlantic halibut, and Atlantic mackerel have been documented eating juvenile lobsters in the Gulf of Maine, but the extent to which lobsters make up their diet is unknown.


The research team has been examining the stomach contents of these species to look for juvenile lobster remains and noting the developmental stage of any whole lobsters. Black sea bass and striped sea bass may now also pose a threat to juvenile lobsters, so the team samples their stomach contents when they are encountered.

Preliminary results from fall 2021 through fall 2022 surveys found lobsters in the diets of Atlantic cod, Atlantic halibut, red hake, and white hake. However, they were in very low abundance in comparison to other previtems found in the fish stomachs.

This project is ongoing, and more results will be available once all survey data is collected and analyzed. (*These results are preliminary and subject to change with peer review.)



Little is known about the predators of American lobster in coastal Maine and New Hampshire waters, making it difficult to accurately estimate mortality of juvenile lobsters.

Not only will this study provide insight into the species that are feeding on lobster, but it will also expand our knowledge of the overall diets of the seven fish species involved in this study. All of this information can be used to obtain a better understanding of ecosystem dynamics in the inshore waters of the Gulf of Maine.

Bill Tackles Problem of Abandoned Fishing Gear

Tarr Takes Next Major Step to Protect North Atlantic Right Whales, Marine Environment, and Commercial Fisheries



BOSTON - Having successfully pursued significant measures over the last several years to protect endangered North Atlantic Right Whales in Massachusetts, State Senate Minority Leader Bruce Tarr (R-Gloucester), the Senate Chair of the legislature's Coastal Caucus, is taking another major step, with other members of the caucus, to protect the whales, the marine environment, and the state's commercial fisheries, by filing SD.3009, "An Act Relative to Abandoned Fishing Gear," which would establish the legal framework for this chronic nemesis to be removed from the state's waters through appropriate regulations promulgated by the Massachusetts Division of Marine Fisheries. This bi-partisan, bi-cameral legislation has garnered early co-sponsorship from Senator Patrick O'Connor (R-Weymouth) and Representatives Ann Margaret Ferrante (D-Gloucester) and Kathleen LaNatra (D-Kings-

"Left unchecked, abandoned fishing gear poses several threats to our marine environment and ecosystems," said Tarr. He added that, "It 'ghost fishes,' increasing mortality without any harvest benefit, it presents a major risk for entanglement for right whales and other species, it clutters and pollutes the ocean floor, and it presents ongoing problems for coastal communities that have when it washes ashore and must be collected and disposed of before it does further damage."

"Maintaining clean waterways, coastlines, and fishing areas is incredibly important for our oceans and the marine environment," said O'Connor. "Our commercial fishing partners have been strong advocates for their industry and this legislation provides a solution to remove debris and gear that may wash ashore that has been difficult to remove in the past.'

"Our communities depend on a clean and unobstructed ocean. Abandoned and unused fishing gear threatens navigation of vessels, as well as the travel lanes of some of our marine species," said Ferrante. "This bill allows for the removal of legitimately abandoned fishing gear, protects marine life, while maintaining the private property rights of our fishermen and lobstermen.'

"Abandoned fishing gear presents a clear threat to the health and safety of marine wildlife and our ocean ecosystem as a whole. Yet, current statute prevents us from cleaning up our oceans and being proper stewards of our most important and vital resource," said LaNatra. "I am proud to co-sponsor this legislation to ensure that our oceans and waterways are not being cluttered by gear that is no longer providing any economic benefits to the Commonwealth, and only adds to the threats that our marine ecosystems face today.'

Currently, because Massachusetts law treats abandoned gear as private property even when it is unclaimed and no owner can be identified, state regulators at the Division of Marine Fisheries (DMF) cannot effectively develop and implement regulations to facilitate the systemic removal of the gear from state waters despite the clear and multiple environmental threats it poses on a continuing basis. SD.3009, "An Act Relative to

to deal with this form of pollution Abandoned Fishing Gear" would reframe and restructure relevant portions of state law to allow the agency to engage the public process of creating new regulatory measures to allow the gear to be responsibly removed while respecting private property considerations.

> "Derelict fishing gear has no place in our environment. Over 9% of fishing gear is lost or abandoned annually, but outdated state laws prevent efforts to recover it. This is a persistent problem—abandoned gear is a threat to endangered right whales, a safety hazard for mariners, a nuisance on our beaches, and a costly burden for municipalities to clean up," said Department of Fish and Game Commissioner Tom O'Shea. "Thank you to Senator Bruce Tarr for leading this effort to modernize state law and streamline our department's efforts to recover derelict gear."

> The filing of the bill comes following months of research on the subject by the DMF, and collaboration with Tarr and other legislators, with a focus on prioritizing the protection of right whales while recognizing the high price currently being paid by those in the commercial lobster fishery to protect this endangered species through the extreme economic sacrifice of enduring fishery closures that last for months and prevent harvesters and others from being able to earn a living.

> "Abandoned and lost fishing gear can persist for many years on the ocean floor, in the water column, and on our beaches," said Massachusetts Division of Marine Fisheries Director Daniel J. McKiernan. "We are grateful to the lobster industry leaders and conservation community leaders who came together with us to devise strategies to dispense of this marine debris and minimize the ecological impacts that it could create.'

> "The Massachusetts Lobstermen's Association (MLA) is proud to sup

port the Abandoned Gear Bill that will help modernize the law to help local communities with their beach cleanup efforts," said Executive Director of the MLA, Beth Casoni. "The commercial lobster industry also helps with many of these cleanup efforts to maintain clean beaches for everyone to enjoy. We look forward to seeing this bill through to the end.'

The filing of the bill follows several other initiatives spearheaded by Tarr, with the overwhelming support of the legislature, to protect right whales and support the state's commercial fishing industry over the past several years.

They include:

FUNDING FOR DIRECTED PATROLS BY THE MASSACHUSETTS ENVIRONMENTAL POLICE (MEP) OF AREAS CLOSED TO FISHING DUE TO THE POTENTIAL FOR RIGHT WHALE PRESENCE

Tarr secured \$250,000 in Fiscal Year 2022, and again in Fiscal Year 2024 for these targeted efforts to prevent harm to right whales during the peak times for their presence in Massachusetts waters. These efforts came at the request of the Massachusetts Lobstermen's Association, because of the organization's concern that injuries not related to active fishing could occur even as lobster harvesters were making the significant economic sacrifices caused by state waters being closed to lobstering.

The funding from this program has been highly effective in protecting right whales through several measures, including:

PREVENTION OF ILLEGAL ACTIVITIES:

Increased patrols act as a deterrent to illegal activities in closed areas. These areas are designated to protect right whales during critical times, such as calving and feeding. Patrolling helps enforce regulations and prevents unauthorized fishing activities, reducing the risk of entanglement and collisions between whales and fishing gear.

REDUCTION OF ENTANGLEMENT RISKS:

Closed areas are often established to minimize the risk of entanglement, a significant threat to right whales. Fishing gear, such as lines and traps, can pose a danger to whales if they become entangled. Patrolling closed areas ensures that fishing activities comply with regulations, reducing the likelihood of abandoned or improperly managed gear that could entangle right whales.

ENHANCED RESPONSE TO GEAR DEBRIS:

Increased patrols enable authorities to respond promptly to any fishing gear debris found in closed areas. Abandoned or lost gear, known as fishing gear debris, can continue to pose risks to marine life. Patrols help identify and remove such debris, preventing potential harm to right whales and other marine species.

PROTECTION OF CRITICAL HABITATS:

Closed areas are often designated in important habitats for right whales, such as calving grounds and feeding areas. Patrolling ensures that these critical habitats remain free from disturbances that could disrupt the natural behavior of the whales. Protecting these areas contributes to the overall well-being and reproductive success of the right whale population.

RESEARCH AND MONITORING OPPORTUNITIES:

Patrolling closed areas provides opportunities for research and monitoring efforts. Observations made during patrols contribute valuable data on the behavior, health, and distribution of right whales. This information is essential for implementing effective conservation measures and adapting strategies to better protect the species.

FUNDING FOR GEAR DESIGNED TO PROTECT RIGHT WHALES

In Fiscal Year 2023, Tarr authored successful legislation to create a program for grants to lobster harvesters for replacement gear required for the protection of right whales. The grant program, funded at \$500,000, provided the funds needed for harvesters to be able to afford the substantial cost of such essential fishing gear as "weak rope," constructed to break in the event of high stress due to a whale entanglement.

DMF awarded approximately

\$475,000 to 162 Massachusetts lobster fishers to purchase whale safe rope and gear marking supplies. The awards ranged from \$1,000 to \$3,025.

ENDANGERED SPECIES: NORTH ATLANTIC RIGHT WHALES

The North Atlantic right whale is recognized for their massive size, distinctive callosities on their heads, and broad, deeply notched tails. These marine giants once thrived in the waters along the eastern coast of North America; however, their population has dwindled to critically low numbers, making them one of the rarest large whale species on the planet.

One of the defining features of North Atlantic right whales is their annual migration in which they embark on a seasonal pilgrimage, covering vast distances from their feeding grounds in chilly northern waters to their calving areas in the warmer, southern regions. The North Atlantic right whale's migration typically occurs in late fall and early winter when they travel southward to give birth and nurture their calves in the subtropical waters off the southeastern United States.

During the spring (March to

June), North Atlantic right whales can be spotted in the waters of New England as they migrate northward. This period coincides with their return journey from their calving grounds in the warmer southern waters. As the waters in New England begin to warm up, these whales travel along the Atlantic coast, feeding on plankton-rich areas.

It is important to note that the exact timing of their arrival and departure may vary each year, influenced by factors such as oceanographic conditions and the availability of their primary food sources. Understanding the intricacies of their migration patterns and addressing the threats they encounter during these journeys are critical steps in the conservation efforts, which aim to track and protect these whales during their migrations, especially given the various threats they face in their journey, such as vessel strikes and entanglement in fishing gear.

litigation. Let it be clear: litigation is not our preferred course of action, particularly as a self-funded fishing organization with limited resources. Nonetheless, we refuse to stand by while NOAA unlawfully jeopardizes our livelihoods. We have reached a breaking point, and we will not tolerate any further unjust attacks on our industry. Enough is enough!

We understand the critical importance of the approximately 250 square miles Wedge area for these lobstermen, particularly during these challenging economic times and amidst historically low (indeed, zero) North Atlantic Right Whale sightings. Our belief in the necessity of this area is not unique to the MLA alone; Congress itself prohibited NOAA from closing the Wedge through the Consolidated Appropriations Act of 2023. NOAA cannot disregard the will of Congress and target our lobstermen without facing a response from us.

The Massachusetts Lobstermen's Association is a member-driven organization that accepts and supports the interdependence of species conservation and the members' collective economic interests. We will continue to fight for reasonable, sensible, and legal measures to protect the NARW. The Wedge Closure is not reasonable, sensible, or legal.







Examining the Lobster Boom and Potential Threats through Collaborative Research with the Lobster Fishery

New England is home to some of the oldest and most iconic fisheries species in the U.S., such as the American lobster. Lobster populations and landings in coastal Maine have been consistently high over the past couple of decades, yet the fishery faces a multitude of threats currently. Several mechanisms have been proposed behind this increase in lobsters, including release from cod and other predators in coastal waters as well as bottom-up augmentation from herring bait. Yet new potential predators have emerged, such as black seabass and other potential predators of juvenile lobsters expanding into the Gulf of Maine. This talk will discuss two decades of collaborative research with the lobster industry examining hypotheses of why lobster populations boomed over the past several decades as well as the industry's observations of and potential impacts from these newcomers. Finally, we will introduce a new project partnering with the Massachusetts Lobster Association examining impacts to and the adaptive capacity of the lobster fishery.

Let's Talk about Offshore Wind, Larval Habitats and Life as a Lobsterman

The Sea Grant American Lobster Initiative, funded by the National Oceanic and Atmospheric Administration's National Sea Grant College Program, is addressing critical knowledge gaps about American lobster and its iconic fishery in a dynamic

and changing environment. The initiative, which began in 2019, supports both scientific research and a regional Sea Grant extension program in the Northeast U.S. Together, the research and extension components of this initiative will develop and share new knowledge and understanding with industry stakeholders and resource managers from Maine to New York. This session will feature three newly funded research projects that address issues that are directly relevant to the lobster industry. We will provide snacks and coffee to promote attendance and a more informal feel to the session. The session will be an opportunity for the research teams to share their upcoming plans for their research projects. We hope to host an open discussion about the projects to hear input from fishermen and managers on what products might be useful around each of the research topics. Projects highlighted will include: 1) the acoustic impacts of offshore wind development on lobsters. 2) stress, social disruption, trust, and adaptive capacity of the lobster industry, and 3) surface convergences as a widely undersampled microhabitat for American lobster larvae.

MA Division of Marine Fisheries & MA Environmental Police Roundtable

The Massachusetts Division of Marine Fisheries (DMF) is responsible for the conservation of marine fisheries resources. This includes managing both recreational and commercial harvesting of saltwater finfish, shellfish, and crustaceans like lobster and crab. The DMF oversees policy which promotes sustainability while balancing the requirements of a complex coastal fishing industry. State officials will be on hand to present new information on lobster stock status, fishery trends, whales, and discuss other issues of concern to the industry. The Massachusetts Environmental Police protect the environment and natural resources through enforcement, education, and public outreach. The "U.S. marine resource laws exist to ensure sustainable fish populations; protect threatened marine species and the habitats they live in and to ensure these resources are around for future generations to enjoy. When people cheat and willfully violate fishery management regulations it puts those who comply with the rules at a significant disadvantage.




Vessel operators are responsible for giving the dealer(s) the 14 digit eVTR number created on their reporting app.

Federal dealers are required to report that eVTR number on all federal dealer reports. The eVTR number is how GARFO matches the trip report to the corresponding dealer report.

VINEYARD WIND

2023 Offshore Construction Update

SUCCESSFUL INSTALLATION OF FIRST TURBINE FOR VINEAYRD WIND 1

In October, Vineyard Wind announced the successful installation of the first GE Haliade-X wind turbine for the Vineyard Wind 1 project, the nation's first commercial-scale offshore wind project. The completed turbine is comprised of one tower, three blades, and one nacelle. The fully assembled 13-megawatt machine represents the largest installed turbine in the Western Hemisphere and can power more than 6,000 homes and businesses in Massachusetts. The turbines being installed for Vineyard Wind 1 are spaced 1 nautical mile apart, a distance that is greater than the spacing used in any other operating wind project globally.

VINEYARD WIND 1 DELIVERS POWER TO MASSACHUSETTS GRID

As part of the initial commissioning process, at 11:52 PM on Tuesday, January 2, 2024, the first turbine delivered approximately five megawatts of power to the grid. Additional testing is planned for both on and offshore in the coming weeks. Five turbines are expected to be operating at full capacity early in 2024. (Source: *Vineyard Wind.com*)

2023 CABLE INSTALLATION UPDATE

In the summer of 2023, the installation of the Vineyard Wind 1 offshore export cables were completed. These cables are 35 miles in length and travel from Covell's Beach in Barnstable to the offshore substation in Lease Area OCS-A $_{\rm 0501}$

The Vineyard Wind 1 inter-array cables have been partially installed with two strings (18 cables) completed to date. Inter-array cable installation will continue in summer 2024.

2023 FISHERIES SCIENCE UPDATE

In 2023, Vineyard Wind completed a number of scientific fisheries surveys during construction. The surveys were conducted on local fishing vessels by the University of Massachusetts, School of Marine Science & Technology.





Vineyard Wind completed two drop camera surveys (May and September), three trawl surveys (May, August, and November), a ventless trap and larval survey (May through October), and a Highly Migratory Species survey (May through September). Three years of pre-construction surveys have been completed with an additional year of surveys during construction. Post-construction surveys are planned to begin in 2025 and continue for three years to complete the Before-After-Control-Impact (BACI) analysis.

ELECTRONIC SERVICE PLATFORM (OFFSHORE SUBSTATION) 2023 CONSTRUCTION UPDATE

As of January 24, 2024:

- 47 Monopiles installed with 15 remaining for installation in 2024
- 8 completed wind turbines installed
- 22 monopiles with a transition piece
- 17 monopiles

Over 40 local fishing vessels have worked on the Vineyard Wind 1 project thus far. Wind turbine installation activities will continue through the winter with monopile installation beginning again in spring 2024.

US Coast Guard approved lighting pieces have been attached to each of the installed monopiles in Lease Area OCS-A 0501 to increase their visibility. Safety vessels will be monitoring the Wind Development Area 24/7, standing by on VHF channel 16.



VINEYARD WIND

Vineyard Wind 1 Fisheries Compensatory Mitigation Program

Vineyard Wind 1 LLC (Vineyard Wind) is constructing an 800 MW offshore wind project located in Lease Area OCS-A-0501 approximately 15 miles south of Martha's Vineyard. The lease area (also referred to as the Wind Development Area or WDA) is approximately 63,000 acres and where 62 wind energy turbines and one electrical platform will be installed in a grid pattern spaced one nautical mile apart in a north/south/east/west direction.

Vineyard Wind has created a fisheries compensatory mitigation program with a primary objective to provide fair, equitable compensation to commercial fishermen for economic losses attributable to Vineyard Wind 1's construction, operations, and decommissioning activities.

Three escrow funds have been established to compensate affected fishermen in Massachusetts, Rhode Island, and Other States (Connecticut, New Jersey, and New York). Compensation may also be available to shoreside businesses in Massachusetts.

For commercial fishermen, the first phase of the program will be the eligibility phase, which will require commercial fishing vessel owners to qualify for compensation payments based on defined eligibility criteria. Once qualified, a commercial vessel owner may elect to participate in either an expedited claims process or an individual claims process, both of which are based on a commercial fishing vessel owner's historic revenue dependence on the WDA but require different levels of proof. Fishermen will not need to demonstrate economic impacts from Vineyard Wind 1 to qualify for the program or receive compensation payments.

The Vineyard Wind 1 Fisheries Compensatory Mitigation Program is scheduled to be launched on March 4, 2024. Information about the program, including how to apply, will be available on the program's website: www.vwlfisheriescomp.com. Once the program launches, commercial fishermen will be able to apply to the program to establish eligibility. The program's eligibility criteria for commercial fishing vessel owners are provided on the following page.





Exploring Larvae & Settler **SURVIVAL**

Researchers work to understand the "recruitment bottleneck": why few lobsters reach adulthood in southern New England

EXPLORE the PROJECT

To understand the collapse in southern New England, the team is measuring the abundance and distribution of lobster larvae and juveniles in Rhode Island waters. To collect samples of lobster larvae, the researchers are towing fine mesh neuston nets behind boats at six locations in Rhode Island. They are using two methods to sample juvenile lobsters settled on the seafloor: scuba divers using suction hoses to collect organisms from ocean sediment; and using shallow caged boxes filled with rocks mimicking lobster habitat to collect juveniles at depths beyond the reach of scuba divers.

READ the RESULTS

From south of Cape Cod (MA) to Rhode Island Sound, the lobster population has rapidly and drastically decreased as fewer lobsters have survived to reach reproductive age – a phenomenon known as "recruitment bottleneck." The data the team has collected will be used to test whether the recruitment bottleneck is occurring in the larval stage when lobsters are still floating higher in the water column or during the juvenile stage when lobsters are settling on the seafloor. This project is ongoing; researchers are collecting and analyzing the data.

UNDERSTAND the IMPORTANCE

A better understanding of the early life stages of the American lobster will provide insight into survival during this critical period of time. It is currently unknown why and how a recruitment bottleneck is occurring in southern New England's lobster stock.

Determining the factors impacting recruitment success and creating this bottleneck will be crucial for efforts to rebuild the lobster stock in southern New England.

The Massachusetts Lobstermen's Association (MLA) Legal Defense Fund (LDF) needs your support now more than ever. This dedicated fund is for the purpose of defending the Massachusetts commercial lobster fishermen from legal and fisheries management actions that could seriously impact our commercial lobstermen's ability to conduct their businesses and earn a living.

Currently, the MLA is actively engaged in three separate lawsuits that could have negative impacts on the commercial lobster industry and is working with our lawyers in Washington D.C. and here in the Commonwealth to fight for you and your industry.

UPDATE 2/16/2024 (Washington D.C.) Case 1:21-cv-02509-JEB - Maine Lobstermen's Association, et al. v. NFMS

Please recall our long saga fighting against NMFS' 2021 Biological Opinion has finally resulted in a win, and what a win it was! On June 16, 2023, the D.C. Circuit Court issued its ruling, unanimously finding that Judge Boasberg was wrong to uphold the Biological Opinion and ruling against NMFS on every ground raised by us. This is an excellently written opinion that not only finally understands the stakes faced by our members, but fully holds NFMS to account for its illegal attempts to destroy our industry.

While the decision in the case is now the law of the land, on November 29, 2023, we filed a Motion to recover the MLA's legal fees and costs expended in fighting against the United States Government pursuant to the Equal Access to Justice Act, which provides in pertinent part that "a court shall award to a prevailing party other than the United States fees and other expenses...incurred by that party in any civil action...., unless the court finds that the position of the United States was substantially justified

or that special circumstances make an award unjust." Here, we rightly argue that the MLA was a prevailing party, the Government's position (in the litigation and at the agency level) was not substantially justified, and consequently the MLA is entitled to recover its legal fees and costs incurred in the matter.

While the Motion is still pending before the Court, the Government asked us to stay that Motion so we could try to negotiate a settlement. We are actively negotiating with the Government and expect to have more news in the next couple months.

UPDATE 02/16/2024 (Washington D.C.) Case 1:18-cv-00112-JEB - CENTER FOR BIOLOGICAL DIVERSITY et al v. ROSS et al.

This case is finally coming to a close, as Judge Boasberg granted ours and the government's motion to dismiss the NGOs case. He also vacated most of his old opinions, leaving in place some minor ones that do not affect us going forward.

We have no doubt that the NGOs will bring a similar lawsuit after 2028 when the next Biological Opinion comes out, so having this case dismissed and the old rulings vacated sets us up well for continued success.

Overall, we are very pleased to have this case finished and for the NGOs' attempts to force NMFS to regulate our industry with even more draconian rules to have been put firmly to bed.

UPDATE 2/16/2024 (District of Massachusetts Case) Case No. 1:24-cv-10332-WGY; MLA v. NMFS et al

Last year NMFS illegally extended the 2022 Wedge Closure to close the Wedge from February through April 2023. We challenged this decision in Court and the Court agreed we were right on the law, but ultimately decided not to stop it because we could not show irreparable harm.

NMFS is now at it again, attempting to convert its illegal 2023 Wedge

Closure into a Permanent Final Rule. We submitted a robust comment to the proposed final regulation explaining to NMFS why its proposed final rule is illegal.

Despite this, NMFS proceeded with the illegal wedge closure, ignoring Congress' clear mandate not to further regulate the lobster industry and relying on the same illegal science that the D.C. Circuit struck down.

We moved for a preliminary injunction to stop this before it could go into effect this season. NMFS has until February 23, 2024 to file its opposition brief. The Court will set a hearing for the following week.

MS has attempted to intervene in the matter, and we intend to strongly oppose this and make the Court aware of MS's long history of adversarial actions.

The commercial lobstermen's businesses are at stake as well as the thousands of jobs and shore side businesses that depend upon the continued success of the commercial lobster industry. The commercial lobstermen in Massachusetts are NOT to the problem and have done everything asked of them by National Marine Fisheries Service and have been working under the strictest conservation rules for the right whales anywhere in the world since 2014. Yet here we are, still fighting these lawsuits to keep the Massachusetts commercial lobstermen fishing.

The Massachusetts Lobstermen's Association has been actively involved in these lawsuits since 2018 and we need your generous support today to continue our fight to keep the commercial lobstermen fishing. As we all know, any legal action costs lots of money and over the last 5 years the Massachusetts Lobstermen's Association Legal Defense Fund has spent over \$300,000 fighting these legal battles. 
